7. That, I agree that my security detail be terminated unilaterally by the PSPG once he/she/they fail to attend any official duties required of a PNP personnel;

8. That, I also agree for termination of my security detail once I fail to submit letter request for extension or fail to comply the other provisions of this undertaking.

9. That I shall allow my PSP to have at least one **(1) day-off every week** which we shall agree upon.

10. That I shall treat my PSPs professionally; if duty extends beyond 8 hours, shall provide the protective security with decent shelter, meal and transportation allowances.
